Criminal Justice Agency Employment Websites

For students considering a career in criminal justice, it is never too early to begin researching the requirements, benefits, and working conditions of various jobs. This list of 50 websites from criminal justice agencies provides prospective employees with important information that will help you determine if a career in criminal justice is for you. With a little bit of research on the Internet, you can develop your own list of agencies.

Although a college freshman cannot obtain the qualifications for one of these positions at such an early stage, it is easy for a young person to eliminate himself or herself from being considered for criminal justice employment. You should investigate the disqualifying conditions that many agencies publish about behavior, such as drug use, speeding, and legal infractions (see the Atlanta Police Department for one of the most extensive lists of disqualifying conditions).

Explore the websites of these criminal justice agencies, note the qualifications and benefits for their various positions, and think about the working conditions. You may wish to pursue an internship with one of these agencies to determine if this is a career that you want. It is important that you research agencies that you wish to consider so that you can present yourself as knowledgeable, trustworthy, and motivated. Simply having a college degree may not be sufficient to land a job in one of the agencies you desire. You must also demonstrate that you have the background and character that they are seeking. Employment with many of these agencies is extremely competitive, so it is never too early to start crafting an impressive resume.

Federal Criminal Justice Agencies

Secret Service

The U.S. Secret Service is one of the premier law enforcement agencies in the country. It has an extensive website that provides detailed information on what one must do in order to be considered for one of their positions in either the uniform division or as a special agent. One interesting aspect of working for the Secret Service is the bonus pay for speaking a foreign language. Applicants may get a one-time bonus of 25 percent of their base pay if they can demonstrate proficiency in selected languages. The website includes a detailed entrance exam study guide to help applicants prepare for the application process.

Federal Bureau of Investigation (FBI)

The FBI has several paths for prospective applicants. For instance, the STEM (science, technology, engineering, and mathematics) career path allows agents to use their expertise in forensic science, computer technology, cyber security, electronic surveillance, biometrics, and encryption. Applicants with skills in forensic accounting, foreign languages, and surveillance also can find exciting careers in the FBI. This website includes detailed information on eligibility, training, as well as extensive benefits offered by the FBI. Those selected to join the FBI will undergo extensive training at the FBI Academy. Candidates are assessed on six dimensions of suitability including: judgment, conscientiousness, integrity, emotional maturity, initiative, and cooperation.

Transportation Security Administration

Several jobs within the Transportation Security Administration are open to qualified applicants. These jobs include communications specialist, explosive detection K-9 handler, screening procedure specialist, and transportation security officer. This website lists the occupations that are currently seeking applicants for specific geographical locations. Applicants must be able to obtain and maintain a Secret Clearance, must pass pre-employment drug screening and random drug alcohol testing, and must be available for occasional travel to perform official duties.

U.S. Immigration and Customs Enforcement (ICE)

U.S. Immigration and Customs Enforcement (ICE) protects the United States from cross-border crime and illegal immigration that threaten national security and public safety. ICE focuses on immigration enforcement, terrorism prevention, and transnational criminal threats. Within ICE, there is a Homeland Security Investigations agency that targets transnational criminal enterprises. These investigators conduct investigations involving national security threats, terrorism, drug smuggling, child exploitation, human trafficking, illegal arms export, financial crimes, identity fraud, benefit fraud, and commercial fraud. The website includes information on how to apply for the various occupations within ICE.

US Border Patrol and Protection Service

Border Patrol agents are responsible for patrolling international land borders and coastal waters. The mission is to detect and prevent illegal entry and smuggling of aliens into the United States. Additionally, they seek to prevent terrorists and terrorist weapons from entering United States, as well as prevent the illegal trafficking of people, narcotics and contraband. The website provides detailed information on the full range of benefits this federal agency offers. Applicants must pass a polygraph examination, meet drug use guidelines, agree to random drug tests, and submit to an intensive background investigation, including a personal interview. The website also provides study guides for the employment process, including a preparation manual for the entrance examination, additional practice questions for the logical reasoning test, and a physical readiness program guide.

U.S. Postal Inspection Service

The mission of the U.S. Postal Inspection Services is to support the U.S. Postal Service and its employees, infrastructure, and customers; defend the nation's mail system from illegal or dangerous use; and ensure public trust in the mail. U.S. postal inspectors are federal law enforcement officers who carry firearms, make arrests, execute federal search warrants, and serve subpoenas. Inspectors enforce the roughly 200 federal laws related to criminal offenses that adversely affect or entail fraudulent use of the U.S. mail, the postal system, postal employees, and customers. This website provides information for applicants on eligibility, benefits, and working conditions.

Probation and Pre-trial Services

Working as a probation and pre-trial services officer in the federal court system can be a rewarding career. The site details the various duties that these officers perform including conducting investigations and preparing reports; enforcing court-ordered supervision; maintaining personal contact with defendants and offenders to assess compliance and risk factors; and implementing treatment and violation proceedings through assessment, monitoring, and counseling. The site details the compensation for these positions based upon length of service.

Federal Bureau of Prisons

The Federal Bureau of Prisons has a range of jobs that criminal justice majors may be interested in pursuing. These jobs include correctional officer, clinical psychologist, and drug treatment specialist. Applicants are expected to have successfully completed a four-year course of study with a bachelor's degree or have at least three years full-time general experience in a position of responsibility. Applicants with at least nine semester hours of graduate study in criminal justice or criminology are eligible for employment at a higher level. Applicants must be flexible in working long and irregular hours, unusual shifts, and holidays during times of institutional emergencies.

Internal Revenue Service Criminal Investigation Special Agent

The Internal Revenue Service has positions that are of interest to criminal justice students. Specifically, the job of Criminal Investigation Special Agent has many qualities in common with police detective. The special agent's mission is to investigate potential criminal violations of the Internal Revenue Code and related financial offenses. As financial investigators, these agents fill a unique niche in the federal law enforcement community. Due to increased use of automation for financial records, special agents are trained to recover computer evidence. Along with their investigative skills, they use specialized forensic technology to recover financial data that has been encrypted, password-protected, or hidden by other electronic means. In addition to working in regional field offices across the United States, these agents may be assigned a limited number of international assignments including Canada, Mexico, Columbia, Barbados, London, Germany, Iraq, and Hong Kong. There is a physical and medical examination, a full background check, and a tax audit.

Once a candidate has accepted the final offer, they must pass the Iowa Law Enforcement Academy to become a fully certified peace officer.

The website also includes a 12-minute video detailing the physical fitness test that each recruit must successfully complete.

Applicants must successfully complete a background investigation, psychological examination, and a medical examination,

San Jose Police Department

The San Jose Police Department has an online application. Requirements include 40 semester hours or 60 quarter hours from an accredited university. Four years of military service may be substituted for the college credit requirement. The department offers an "all in one" weekend for testing out-of-state applicants who live three or more hours from the city of San Jose, or active military personnel. There is also extensive information on how to prepare for the various tests required by the department.

climb through a window 4 feet above the ground, and complete the total course of 160 yards in a maximum time of 47 seconds. The website also provides information on benefits and disqualifying conditions.

The Maryland Office of the Public Defender recruits both entry-level and experienced trial attorneys. Additionally, they seek applicants for positions as interns, law clerks, and social workers. Most interns work in district offices assisting trial attorneys in the representation of adult and juvenile clients in criminal cases. The public defender's office has 12 district offices throughout the state of Maryland. Some of the offices offer unique opportunities to work closely with attorneys in a more highly specialized area of the law including post-conviction defense, parental defense, forensic, and mental health. The site provides instructions on what materials college students must submit to be considered for employment. These include a current resume, cover letter, law school transcripts, list of references, and a completed applicant essay.

The attorney general is Pennsylvania's chief law enforcement officer and is responsible for prosecuting organized crime and public corruption. This law enforcement effort includes a criminal investigation unit, a drug-law enforcement program, direction of the statewide and multi-county investigating grand juries, and a Medicare fraud control section. The website includes information on how to apply for positions as attorneys, administrative staff,

investigative staff, and secretary or legal assistants. Within the investigative section, agents may be assigned to various units including, narcotics, technical services, computer forensics, and intelligence. The minimum experience in training for an entry-level position includes a bachelor's degree from an accredited university and four years of investigative or paralegal experience. Candidates must successfully complete the interview process and pass a background investigation.

Office of the Fulton County District Attorney-Atlanta Judicial Circuit

The Fulton County, Georgia, district attorney prosecutes all indictable offenses, as well as those that may be charged by accusation and litigates these offenses in the Georgia trial and appellate courts. The office is also responsible for prosecuting felony and misdemeanor offenses committed by juveniles. The office currently retains a staff of 40 assistant district attorneys and 143 staff members, including investigators, victim advocates, and administrative personnel. This office provides internship opportunities for law and undergraduate students. Student interns assist trial attorneys with the preparation of cases for trial and are given assignments and exposed to a wide range of prosecutorial functions, including research, drafting of pre-trial motions, and interviewing witnesses. The office accepts résumés continuously for all positions and keeps them on file for a minimum of six months.

Another significant benefit is the applicant's eligibility for the Public Service Loan Forgiveness Program. Under this program, eligible employees with the appropriate type of student loans, sufficient financial hardship, and who have made 10 years of qualifying monthly payments in the appropriate repayment plan may have their remaining student loans forgiven.

Applicants must pass a security background check as well as pre-employment drug screening.

Probation officers evaluate offender's progress and recommend intensity of supervision based on observations from time of conviction to the period of adjustment after release from an institution. These officers assist offenders in securing jobs, maintaining contact with business organizations and employment agencies, and arranging for employment interviews. This site provides extensive information on the duties and responsibilities, minimum qualifications, and salary of the positions located in the Florida Department of Corrections.

These officers engage in electronic monitoring of offenders, ensuring curfews, and searches and drug screenings of those on probation and parole. The probation and parole officer testifies in court and has extensive interaction with court personnel, victims, community agencies, and law enforcement personnel.
